

PRIVACY & DATA PROTECTION NOTICE

The Company privacy commitment

BioCryst Ireland, a Neopharmed Gentili company and its affiliates (collectively 'Company', 'us', 'we' or 'our'), is committed to protecting the privacy of your personal information. This Privacy and Data Protection Notice ("Notice") describes how Company may collect, use, store, process, share, and transfer your personal information, along with how we protect your personal information. Company, as the Controller of your personal information, adheres to applicable privacy laws and regulations including but not limited to the European Union General Data Protection Regulation (GDPR) and local laws or regulations ('Privacy and Data Protection Legislation'). This Notice describes our general practices, but where local laws or regulations require that we process your personal information differently, we will comply with those local laws.

What type of personal information does Company collect?

"Personal information" refers to any information which could identify you directly (such as your name) or indirectly (such as your date of birth). The types of personal information Company collects depends on how you interact with us.

Personal information we may collect and process from you may include:

- Contact and personal information;
 - Full Name
 - Business Address
 - Job title
 - EAACI membership status
 - Contact details
 - Emergency contact details
 - Date of Birth
 - Passport Number
 - Driver's License and/or Personal ID Information
 - Dietary requirements
 - Airline Loyalty Program Number

You can choose not to provide personal information when asked for it, but it may restrict Company ability to provide you with some services you have requested.

We may collect this information directly from you, or through other sources, such as third-party vendors.

How may Company use my personal information?

Company may collect and use your personal information for reasons including, but not limited to:

- FLIGHT AND HOTEL BOOKINGS
- EAACI REGISTRATION

- SUSTENANCE AND MEALS

Please note that specific arrangements, contracts, consents, notices, or other forms of disclosure provided or made available to you may specify more detailed and/or additional uses of your personal information. If we decide to use your personal information for a purpose other than originally intended when we first collected your data, we will provide you with new Notice.

Further information on consent management

The website uses only essential session cookies to track the progress of a registration from page to page until it is complete and submitted i.e. IP address, with purpose to provide these webpages technically to you, and legal basis of legitimate interest in providing you with a functional website.

Why is Company allowed to collect personal information?

Company can collect and use your personal information when any of the following apply:

- You give us your explicit consent to use your data. You can withdraw this consent at any time.
- We need your personal information in order to enter into or perform a contract.

With whom may Company share your personal information?

Company may share your personal information in accordance with data privacy legislation with authorized third-parties for legitimate business purposes, including, but not limited to:

- Company affiliates and parent company, Neopharmed Gentili.
- Selected suppliers including event planners, EAACI event planners, hotel and airlines.

In any case, Company will ensure that such third-parties:

- Comply with applicable data protection laws and the principles of this Notice.
- Only process the personal information for the purposes permitted in this Notice.
- Implement appropriate technical and organizational security measures designed to protect the integrity and confidentiality of your personal information.

Company may transfer, store, or process your personal information with service providers based around the world, including in Türkiye and the European Union (EU). Laws in these countries may differ from each other and from your country of residence. Company takes appropriate steps to ensure personal information is processed and transferred according to applicable laws, but not all countries are subject to the same data protection laws. When necessary, by applicable law, Company ensures appropriate safeguards are in place through the use of written

agreements with recipients that require them to provide certain protections to your personal information, such as Standard Contractual Clauses adopted by the EU. Please contact Company at privacyeu@neopharmedgentili.com for more information regarding these safeguards.

How long will Company retain your personal information

Company will maintain your personal information only as long as is reasonably deemed required for legal, contractual, or business purposes. During these periods, we will take appropriate steps to ensure that the privacy of your personal information is maintained.

Your rights with regards to your personal information

You have certain rights with respect to your personal information, although some exceptions may apply depending on our basis for processing your personal information and the law in your jurisdiction. Depending on these, you may have the right to:

- Ask Company about the processing of your personal information including access to this information.
- Ask Company to correct information you think is inaccurate or incomplete.
- Ask Company to delete your personal information.
- Ask Company to restrict the processing of your personal information.
- Object to the processing of your personal information.
- Ask that we transfer personal information you have given us.
- Withdraw your consent to process your personal information if you have provided it, such as for direct marketing purposes.
- Complain to your local data protection authority, although we ask that you contact us first.

To exercise any of these rights, please Email us at privacyeu@neopharmedgentili.com. If limitations apply, Company will look at each circumstance and provide you with the reason if we cannot comply with your request. As required by law, Company may take steps to verify your identity prior to taking any actions with regard to your personal information.
